Colorado Springs Pregnancy Centers: A foundational life network priority is to support women and men who are facing unexpected pregnancy. We provide medical-grade pregnancy tests, educational information, ultrasounds, early pregnancy care, and STD testing and treatment under the direction of our medical director. Last year, we served 3,896 clients at our pregnancy centers, provided 1,412 ultrasounds, and celebrated 557 babies saved. Our patients also received support through community referrals for housing, food emergency assistance, and other related services. Our parenting program provides opportunities for ongoing one-on-one mentorship, parenting and childbirth classes, and extensive material resources. Bridges of hope, our post-abortion care program, helps women and men process, grieve, and heal from past abortions.
